Dear customers and interested parties,

bielomatik GmbH (hereinafter bielomatik) places a great deal of importance on data protection. That is why we would like to inform you about our data processing in the interest of transparency and of Article 13, 14 of the General Data Protection Regulation (GDPR).

### 3. For what purposes is data collected and what is the legal basis that allows this?

We process the contact data and contract data for our contractual partners for the purpose of contract initiation, contract conclusion and performance of the contract according to Art. 6 (1), letter b) of the GDPR. For promotional purposes we send interested parties offers from bielomatik by mail according to Art. 6 (1), letter f) of the GDPR. In the event of non-payment, we pass your contact data on to collection agencies according to Art. 6 (1), letter f) GDPR.

We process contact data of parties interested in our company and of contractual partners for the purpose of contract initiation, contract conclusion, and complaint processing in accordance with Article 6 (1) letter b) of the GDPR, and also document the customer relationship in a CRM system according to Article 6 (1) letter f) of the GDPR in order to cultivate the customer relationship. Upon the customer's request, we will also send information material in accordance with Article 6 (1) letter a) of the GDPR. We also collect data in accordance with Article 6 (1) letters a) and f) of the GDPR in order to send our customers and interested parties newsletters with trade fair and event invitations and information on our products.

### 4. To what recipients or categories of recipients are data transmitted?

We do not pass your data on to third parties. We commission service providers with tasks; within this framework, your data may become known to the service provider. Such service providers are advertising agencies, IT service providers, and newsletter service providers.

### 5. Transfer to third countries

None of our customer data is transferred to third countries.

### 6. Duration of personal data storage:

The data stored during data collection will be deleted after expiry of the statutory retention and limitation periods, or after expiry of the intended purpose, whichever is longer.

### 7. Data subject rights

bielomatik offers its customers the right to access, rectification, data portability, erasure and restriction of processing and the right to object to data processing in accordance with Article 6 (1), letter f) of the GDPR. Send your query/request to:
